**RULES and REGULATIONS**

1. This is a seafood chowder/gumbo cook-off, but is not limited to seafood as the only ingredient. Chicken, pork, sausage, etc., can be used. **NO IMITATION SEAFOOD IS ALLOWED.**
2. Chowder/gumbo to be prepared by the contestant at home and brought to cook-off in a container, such as a crock-pot or soup pot with a warming device. Please bring your own ladle or spoon.
3. Power will be available on site.
4. Contestants must have a written recipe and agree to its publication without reimbursement. Do not mail recipe with entry form, please bring it with you.
5. All contestants should have their entries to the Entertainment Tent by 9:30 A.M., Saturday, May 23, 2009. Judging will begin promptly at 10:00 A.M. And will continue until noon. Awarding of prize money and trophies will begin at noon.
6. All entries will be judged on **TASTE, RECIPE, INGREDIENTS, and PRESENTATION.**
7. A contestant may enter more than one chowder/gumbo.
8. NO ENTRY FEE.
9. All entry forms must be received by May 23rd.
10. **No entries or setup may be started after 9:45 A.M. Saturday morning. Judging begins promptly at 10:00 A.M.**
